

## **Sponsored Awards Score Report Form 2010**

**DRESSAGE COMPETITORS:** You must use this 2010 Sponsored Awards Score Report Form to submit scores for the Adult Amateur competing at Third and/or Fourth Level.

Your scores could be lost in the mail! IDCTA will NOT be responsible for lost or misdirected mail.

**Scores postmarked after OCTOBER 31, 2010 will not be accepted and will be returned to you.**

### **DESCRIPTION:**

This award is intended for Adult Amateurs that are IDCTA members in good standing and compete at Third and/or Fourth Level. The purpose of this award is to recognize the rider that may not have achieved the 5 score requirements at Third and/or Fourth Level to qualify for IDCTA year end awards but may have earned at least 3 scores at either level. Or, the rider may have achieved the 5 score requirements at Third and/or Fourth Level to qualify for IDCTA year end awards but prefers to qualify for the Sponsored Award in lieu of the IDCTA award for that level. A qualified rider cannot receive both the IDCTA year end awards and Sponsored Awards but may qualify for either or both Sponsored Awards at Third and/or Fourth Level. Fourth Level is sponsored by Fireside Farm and Third Level is sponsored by LegacyUSA.

### **RULES:**

Submit 3 scores at the level, one can be from a schooling show. This award DOES NOT require a score from the highest test of the level.

If a test was scored by two or more judges, the average of the scores given will be used as one score.

To be eligible for awards, rider or owner (if different) must complete at least 5 hours of volunteer work for the IDCTA (Volunteer Form available at [www.IDCTA.org](http://www.IDCTA.org)).

**INSTRUCTIONS:** Perform at least 5 hours of volunteer work recorded on Volunteer Hours Form. Complete one Sponsored Awards Score Report Form with required number of test scores as explained in above rules. Submit with Volunteer Hours Form. Tests must be from the same level for one Horse/Rider Team. Attach copies of legible tests with judges' signature and/or USDF score printout with tests circled. Provide information as requested below.
